Dear Claims Agent,

Prior to the conclusion of your work as a claims agent in this case, the U.S. Bankruptcy Court, Northern District of Ohio, requires that all claims be transmitted in electronic format and submitted on a CD to the courthouse location that is handling the case. The court will use this information to upload the claims data as part of the Court's electronic case file. The data must be formatted as described in this letter in order for us to process the claims properly. You should also provide a contact name and phone number that the Court's IT department can call in case there are technical problems with the data you submit.

The first file we require in order to process the claims properly is a text file that has all the claims listed with the fields defined in Table 1. Each field should be delimited by a pipe (|) character. Each and every field does not have to have data defined but the empty field must be represented and delimited by a pipe (|) character. An example of how this claims data will look is provided in Example A.

The second data item required to process the claims properly is a copy of each and every claim. These files should be in PDF format. The file name of the claim document should match the claim number referenced in the text file that lists all the claims. For example the name of the file that contains a copy of claim number 34 would be 34.pdf.

It is the responsibility of debtor's counsel to ensure the claims agent provides the requested claims data to the Clerk at the conclusion of the claims process. No application for final compensation for claims services (if applicable) or motion to terminate retention of the claims agent will be granted until the Clerk verifies the receipt and accuracy of claims data.

Your cooperation in this matter will ensure the timely application of the claims to the docket of the case.
